# TERMS AND CONDITIONS

# Your reservation is handled by CUBA TECH & TRAVEL, a division of TECH & TRAVEL COMPANY

CUBA TECH & TRAVEL and our affiliates provide our products and services to you subject to the following terms and conditions. Please read these terms and conditions of use ("Terms and Conditions") before using this website ("Site"). You consent to these Terms and Conditions when you use this Site, without qualification. If you disagree with any part of the Terms and Conditions, you may not use this Site in any way.

## **SUPPLIER CONDITIONS**

Car rental reservation services are provided by the car rental service provider. Any booking made or order placed by you shall be deemed an offer by you to purchase the relevant items subject to these booking conditions. The contract for the service is therefore between you and the car rental service provider and based on their terms and conditions and their terms and conditions and their policies on collection and delivery of vehicles.

## **PRICES**

Please note prices are not guaranteed until payment is made and accepted. Displayed prices are subject to change but will be confirmed when your booking is completed.

Besides car rental prices, booking fees and/or surcharges may apply. All such charges will be shown during the reservation process.

Additionally, the following charges are payable directly to the car rental company upon car collection:

- \* Refundable credit card guarantees deposit of CUC 300-500 (depending on car model).
- CDW (collision damage waiver) liability waiver of 15-40 CUC per day depending on car model
- \* Airport collection fee of 20 CUC (when applicable).
- \* Additional driver CUC 10 one-off or CUC 3 per day, depending on car Rental Company.
- \* Drop-off charges of CUC 20 300, depending on distance between pick-up and drop-off locations.
- \* Fuel in tank special gasoline 1.50 CUC/I, diesel 1.40 CUC / I.

## **VOUCHER**

Besides our Confirmation E-mail to be received upon completion of the reservation and payment processes, we will send by e-mail a supplier voucher – both documents must be printed and presented upon car collection. CUBA

TECH & TRAVEL ALLIANCE or its affiliates accept no responsibility for delays or the car not being delivered if supplier voucher is not printed and presented to the supplier.

#### **PAYMENT & CANCELLATION POLICY**

Your credit card will be debited for the full amount due upon completion of the reservation process. Accepted credit cards: VISA and MASTERCARD. The charge will be in your selected currency and your bill will state. Payment is for car rental with unlimited mileage - liability waiver, fuel in tank and guarantee deposit are payable locally subject to the rental conditions upon car collection. Advertised prices also include all taxes and booking fees.

Once you have paid for your reservation, the following cancellation policy applies:

- \* If you cancel the reservation 72 hours before your intended car collection date, we will refund you the total amount that you paid for your reservation, minus an administration fee equivalent to 3% of paid amount, with a minimum of EUR 15.
- \* If you cancel the reservation within 72 hours or less of car collection date, we will refund you the total amount that you paid for the reservation, minus the amount of the first day of rental.

Refunds must be requested in writing within 60 days of the date of your intended stay at the hotel. Once this period has passed, no refunds will be made.

We will not make refunds to credit cards, other than the credit card that was used for your booking. We may process refunds via wire transfer, in which case we will deduct any bank charges from the refundable amount. We aim to process refund within 72 hours after receiving your refund request and required information.

Whilst every effort has been made to ensure accuracy and availability, some errors might still occur. Once aware of such incidents we will make all reasonable effort to advise you within 48 business hours of the booking being made. We reserve the right to cancel the reservation and refund all monies paid, but this of course will be without any liability to you.
